## PREPARING FOR THE NEXT PUBLIC HEALTH EMERGENCY



During a public health emergency, such as a large scale disease outbreak or

bioterrorism event, wide parts of the population may need medications or vaccines quickly. In heavily populated areas, this can become a difficult task that must be executed with great efficiency. To address this vulnerability, the Cities Readiness Initiative (CRI) provides direct assistance to large metropolitan areas throughout the nation to build the response capacity needed to provide preventative medications to 100% of their population within 48 hours.

# WHAT'S THE PLAN?

The Riverside County Emergency Management Department (EMD) will be establishing "Point of Dispensing" (POD) sites to distribute medications or vaccines to protect healthy individuals within the general population from biological threats or epidemics.

In addition to PODs managed by the EMD, other areas of the population can receive medications through Closed PODs, which are operated by businesses and organizations. Closed PODs would receive medication from the EMD to distribute to employees, clientele, and their immediate families.

## WE NEED YOUR HELP!

With the help of schools, universities, military installations, businesses and faith and community based organizations the burden on the public PODs can be greatly reduced. Closed PODs will help to decrease the number of people served in public PODs and can reach community members who may have a difficult time moving through public PODs.

Partnering with the EMD will empower your organization to care for employees and their family members. Additionally, Closed PODs reduce long lines and public anxiety, allow resources to be used more efficiently, and protect vulnerable populations.

As with all preparedness activities, the more time we have to communicate and exercise our response plans, the better we will be able to react when an emergency occurs.
